ARTICLES OF ORGANIZATION
FOR

The undersigned has executed these Articles of Organization for the purpose of forming a limited liability company under the laws of the State of Florida.

Article 1. The name of the limited liability company is "B2Bportales.com, L.C." (the "Limited Liability Company").

Article 7. The term of duration of the Limited Liability Company shall be perpetual, unless sooner terminated in accordance with the Operating Agreement of the Limited Liability Company.
