FIRST: These Amended and Restated Articles of Organization (the "Articles") are submitted by First Coast Venture LLC, a Florida limited liability company (the "Company") pursuant to Section 608.411 of the Florida Limited Liability Company Act.

SECOND: The date of filing of the Company's Articles of Organization was March 7, 2000.

THIRD: The Company's Articles of Organization are restated and also further amended to read as follows:

of the occurrence of any other event that terminates the continued membership of any member shall not cause the Company to be dissolved, and upon the occurrence of any such event, the Company shall be continued without dissolution. At any time there are no members, the Company is not dissolved and is not required to be wound up if, within one (1) year after the occurrence of the event that terminated the continued membership of the last remaining member, the personal representative or other legal representative of the last remaining member agrees in writing to continue the Company and agrees to the admission of the personal representative of such member or its nominee or designee to the Company as a member, effective as of the occurrence of the event that terminated the continued membership of the last remaining member.

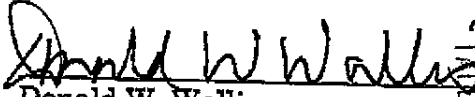
