

**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company (the "Company") shall be REVEILLE TRAINING CENTER, L.L.C.

The name and street address of the registered agent of the Company in the State of Florida is Jeff O'Neill, 1240 Mandy Lane, Astor, Florida 32102.


ARTICLE VI - MANAGEMENT

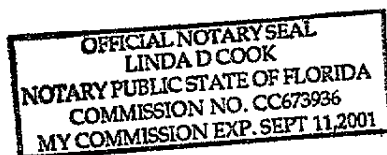
