ARTICLES OF ORGANIZATION OF 1403 YACHT CLUB, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes and files the following Articles of Organization.

ARTICLE I NAME

The name of the limited liability company is 1403 YACHT CLUB, L.C. (the "Company").

ARTICLE II DURATION

The period of the Company's duration shall commence on MARCH 2, 2000 and shall be perpetual, unless the Company is dissolved as provided for by law, by these Articles of Organization or in the Regulations ("Regulations") of the Company.

The Regulations of the Company may also contain any other provisions for the regulation and management of the affairs of the Company not inconsistent with law or with these Articles of Organization. 
