The Company is to be a member-managed Company.

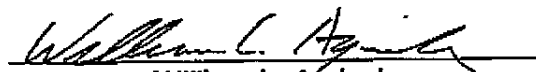
**ARTICLE V****OPERATING AGREEMENT**
