ORIGINAL NAME & FILING

Company and is authorized to make any contracts, enter into any transactions, and make and obtain any commitments on behalf of the Company to conduct or further the Company's business;

(ii) The manager may delegate to a subcommittee of managers, another individual manager, or an employee of the Company any of the manager's responsibilities and authority. This provision does not alter or waive any duty that a manager may have to the Company concerning the manager's exercise of management authority.

(b) Matters Reserved to the Members. Neither the management committee nor any delegate of the management committee has authority to sell substantially all of the Company assets, unless first authorized by members holding 75 percent of the voting power of the membership interests, with the authorization given either by vote at a properly called meeting of the members or by written consent.

ARTICLE VIII

RELATIONSHIP OF ARTICLES OF ORGANIZATION TO OPERATING AGREEMENT

If a provision of these Articles of Organization differs from a provision of the Company's operating agreement, then, to the extent allowed by law, these Articles will govern.
