are made this 26 day of January, 2000, by Myra S. Shapiro.


Explanatory Statement


Myra S. Shapiro, desiring to organize a limited liability company under and pursuant to the provisions of Florida Law applicable thereto, hereby forms a limited liability company for the purposes and on the terms and conditions hereinafter set forth (the "Company"), and hereby certifies to the Florida Department of State as follows:

1. The name of the Company shall be "Sa-Shaw, LLC".
2. The latest date upon which the Company shall be dissolved and its affairs wound up is January 1, 2010.
3. The purposes for which the Company are formed are as follows: to have and exercise all powers now or hereafter conferred by the laws of the State of Florida on limited liability companies (hereinafter referred to as the "Act"); and, to do any and all things necessary, convenient or incidental to the foregoing.
4. The address of the principal office of the Company is 13125 Wexford Hollow North, Jacksonville, Florida 32224. The mailing address is the same.
