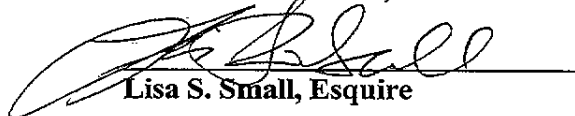

ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I - Name

The name of the Limited Liability Company is DOCUMENT CONSULTING SERVICES, L.L.C.

ARTICLE II - Address

The mailing address and street address of the principal office of the Limited Liability Company is 610 N. M Street, Lake Worth, FL 33460.

ARTICLE III - Duration

The period of duration for the Limited Liability Company shall be perpetual.

ARTICLE IV - Management

The Limited Liability Company is to be managed by the founding members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:

No additional members shall be admitted to the company except with the unanimous written consent of the founding members of the company and on such terms and conditions as shall be determined by the founding members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless the founding members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.
