ARTICLES OF ORGANIZATION OF
MARISCAL PROPERTIES, LLC

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this limited liability company shall be MARISCAL PROPERTIES, LLC, and its principal office shall be located at 417 Medici Court, Punta Gorda, FL 33950 in the City of Punta Gorda, County of Charlotte, State of Florida, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II

PURPOSES AND POWERS
