**ARTICLES OF ORGANIZATION  
OF  
TURBINE POWER, LLC**

Under Limited Liability Company Law of the State of Florida, the undersigned, being a natural person of at least 18 years of age and acting as the organizer of the limited liability company (the "Company") by these articles being formed under the Limited Liability Company Law of the State of Florida (the "Act"), certifies that:

**ARTICLE ONE**

**NAME OF COMPANY**

The name of the Company is Turbine Power, LLC.

**ARTICLE TWO**

**PURPOSE OF COMPANY**

The purpose of the Company is to engage in any lawful act or activity for which limited liability companies may be organized under the Act.

A member acting in his, her or its capacity as a manager of the Company, or a manager, shall not be personally liable to the Company or its members for damages for any breach of duty in such capacity as a manager, except for damages resulting from actions or omissions by such manager, as to which there shall have been a judgment or other final adjudication that establishes that such acts or omissions were in bad faith, involved intentional misconduct or a knowing violation of law, or that such manager personally gained a financial profit or other advantage to which he, she or it was not legally entitled, or that with respect to a distribution the subject of the Florida Limited Liability Act, such manager's acts were not performed in accordance with the Florida Limited Liability Act. Neither the amendment nor the repeal of this Article shall eliminate or reduce the effect of this Article in respect of any matter occurring, or any cause of action, suit or claim that, but for this Article, would accrue or arise, prior to such amendment, repeal or adoption of an inconsistent provision. This Article shall neither eliminate nor limit the liability of a manager for any act or omission occurring prior to the adoption of this Article.
