

**ARTICLE I - NAME**

**ARTICLE III - MANAGEMENT**


The Company is to be managed by one manager or more managers and is, therefore, a manager - managed company.

ARTICLE V - DURATION

The period of duration of the Company shall be perpetual.

ARTICLE VI - REGULATIONS

The Company's Regulations, as defined in the Act, must be in writing and signed by all of the members.

ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS

The right of the members to admit additional members and the terms and conditions of the admissions shall be specified in the Regulations.

ARTICLE VIII - MEMBERS RIGHTS TO CONTINUE BUSINESS

The right of the remaining members of the Company to continue the business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the Company shall be specified in the Regulations.

ARTICLE IX - LIMITATION ON AGENCY AUTHORITY OF MEMBERS

Pursuant to Section 608.424 of the Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.
