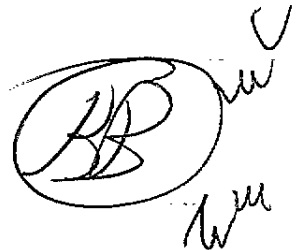
Place of Business and Registered Agent

ARTICLE 10.

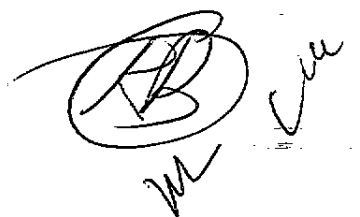
Indemnification of Members and Manager
