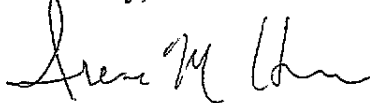

The mailing address and street address of the principal office of the Limited Liability Company is 1177 Longbow Avenue, North Port, Florida 34286.

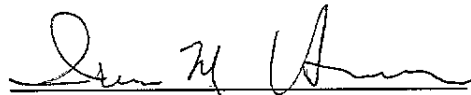
ARTICLE III — Registered Agent & Registered Office

The Limited Liability Company is to be managed by one manager or more managers and is, therefore, a manager-managed company.

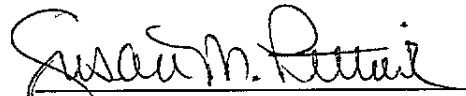

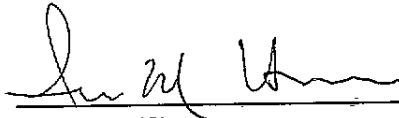
