#### ARTICLES OF ORGANIZATION OF NORTHLAKE CORPORATE PARK LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization:

#### **ARTICLE I - NAME**

The name of the limited liability company shall be **NORTHLAKE CORPORATE PARK LLC** (the "Company").

# ARTICLE II - ADDRESS The mailing address and street address of the Company is c/o Capital Realty Advisors, Inc., 600 Sandtree Drive, Suite 212, Palm Beach Gardens, Florida 33403. ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Operating Agreement.

#### ARTICLE IV - REGISTERED OFFICE AND AGENT

#### **ARTICLE V - CAPITAL CONTRIBUTIONS**

The members of the Company shall contribute to the capital of the Company in cash or property as provided in **Exhibit "A"** attached hereto and incorporated herein by reference.

#### ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTION

Each member shall make additional capital contributions to the Company only on the written consent of the members owning a majority interest of the Company.

#### ARTICLE VII - ADMISSION OF NEW MEMBERS

A. New Members. As provided in the Operating Agreement, no additional members shall be admitted to the Company except with the written consent of the members owning a majority of their collective interests in the Company, which consent shall not be unreasonably withheld.

B. Transfer of Membership. A member may transfer all or a portion of his or her interest in the Company provided such transfer is in conformance with the express provisions of the Operating Agreement, including by first providing a right of first refusal to the members (other than the member proposing to dispose of his or her interest), and secondly if the members owning a majority of interest of the Company (other than the member proposing to dispose of his or her interest) have consented in writing to such transferee. If all members (other than the member proposing to dispose of his or her interest) have waived the right of first refusal, but all such members have not on the other hand so approved in writing of such transferee (which consent shall not be unreasonably withheld), then the transferee shall have no right to participate in the management of the business and affairs of the Company. Notwithstanding the foregoing, in the event only one member exists on the date of transfer, then such transferee shall have the right to participate in the management of the business and affairs of the Company.
