## ARTICLES OF ORGANIZATION

OF

**glass4less, l.l.c.**

The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

### ARTICLE I - NAME

The name of this limited liability company shall be glass4less, l.l.c. (the "Company").


ARTICLE IX - ADOPTION OF REGULATIONS


ARTICLE X - AMENDMENT
