

# ARTICLES OF ORGANIZATION FOR

IYH of South Florida, L.L.C.



Following Chapter 608 of the Florida Statutes, the undersigned does hereby submit these Articles of Organization for forming a Florida Limited Liability Company.

#### Article 1: Name and Principal Office

The name of the limited liability company is **IYH of South Florida**, **L.L.C.** The limited liability company's principal place of business and its mailing address is the 2500 Diana Dr., Apt 108, Hallandale, Florida 33009-4825.

#### Article 2: Duration

The duration of this limited liability company is perpetual.

#### <u> Article 3: Purpose</u>

This limited liability company will engage in investment club or any activity or business permitted under the Florida Limited Liability Company Act.

Article 4: Registered Agent and Registered Office

The name of the limited liability company's first registered agent is Jumpingjaxtax.com, Inc. and its address is 8551 West Sunrise Blvd., Suite 102, Plantation, Florida 33322-4007. As registered agent, Jumpingjaxtax.com, Inc. accepts service of process for the above limited liability company at the place designated in these articles of organization. #### Article 5: Members

The members of this limited liability company are Isaac Mizrachi and Hani Mizrachi, of 2500 Diana Dr., Apt. 108, Hallandale, Florida, 33009.

#### Article 6: Limited Liability Company Operating Agreement

The limited liability company operating agreement regulates the business affairs of this limited liability company.

#### <u>Article 7: Transferability of Member's Interests</u>

Member's interest will be transferred in this limited liability company as described in the limited liability company operating agreement and Florida Limited Liability Company Act.

#### Article 8: Management

The members of this limited liability company will manage the limited liability company. The managing members are Isaac Mizrachi and Hani Mizrachi. Any entity that becomes a member of the limited liability company will have all rights and obligations of a member under the limited liability company operating agreement and the Florida Limited Liability Company Act.

#### Article 11: Member's Rights to Continue the Business

If a member dies, retires, resigns, declares bankruptcy, dissolves, or otherwise terminates continued membership in the limited liability company, the remaining members will continue the limited liability company based upon the contributions to the limited liability company, the operating agreement of the limited liability company, or the Florida Limited Liability Company Act.
