**Articles of Organization
of
TRON TECH OF OKALOOSA-WALTON, L.L.C.**

The undersigned subscriber to these Articles of Organization, desiring to form a limited liability company pursuant to the Florida Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, and being a natural person competent to contract, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a professional limited liability company under the laws of the State of Florida.

ARTICLE I (NAME)

The name of this limited liability company is TRON TECH OF OKALOOSA-WALTON, L.L.C. (the "Company").

ARTICLE II (DURATION)

The Company shall have perpetual duration, beginning on the date these Articles of Organization are filed in the Office of the Secretary of State of the State of Florida.

ARTICLE III (PURPOSE)

Except as limited by Chapter 621 of the Florida Statutes, the Company shall have all of the powers stated in the Florida Limited Liability Company Act, Chapter 608, the Florida Statutes, as such chapter presently exists and may hereafter be amended, and render professional medical services.

ARTICLE IV (PRINCIPAL OFFICE AND REGISTERED AGENT)

The street address and mailing address of the Company's initial principal office shall be 16526 Silverhill Drive, Tampa, Florida 33624. The Company's principal office may hereafter be at such other place or places as the members from time to time may determine. 


