Pursuant to the provisions of FS § 608.411, the undersigned Limited Liability Company adopts the following articles of amendment to its articles of organization:

1. The name of the company is Baredo, LLC.
2. The articles of organization were filed on March 17, 2000.
3. The following amendments of the articles of organization were adopted by the members of the company on April 25, 2000 in the manner prescribed by the Florida Limited Liability Company Act:

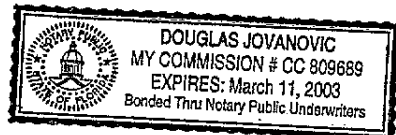
