The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, makes, acknowledges, and files the following Articles of Incorporation.

ARTICLE I

Name

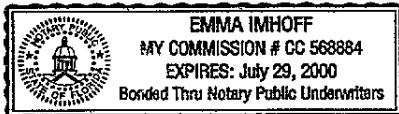
