ARTICLE I

Name

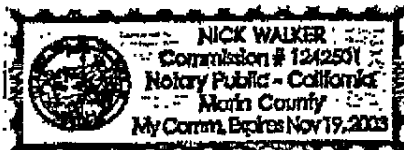

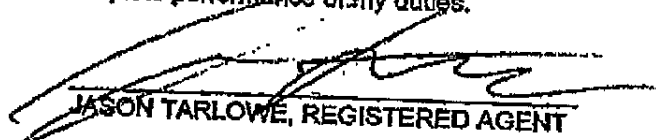

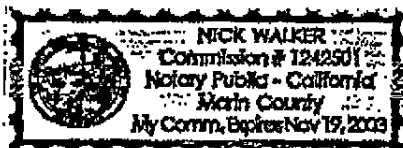
