ARTICLES OF ORGANIZATION OF

WORLDWIDE AIRSHIP OPERATIONS, L.L.C.

A Florida Limited Liability Company

The undersigned (the "Member") acting as the organizer of Worldwide Airship Operations, L.L.C., ("Company") under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE 1

NAME

The name of the limited liability company is:

The remaining Member or Members of the Company shall have the right to continue the business of the Company upon the retirement, resignation, expulsion, bankruptcy or dissolution of a Member.

ARTICLE 8

AMENDMENTS

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the written approval by a majority of the Members of the Company and the approval of the Manager of the Company.

ARTICLE 9

AUTHORIZED REPRESENTATIVE

Under the provisions of the Florida Limited Liability Company Act, Deutsche Luftschiff AG, a member of the Company, authorizes Charles D. Hood, Jr., to file these Articles of Organization as an authorized representative of the Company.
