**ARTICLE I

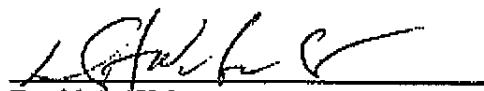

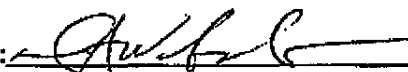
