FOR

FILED

FIRST: The name of the limited liability company is JJG PROPERTY, L.L.C.

SECOND: The period of duration of the limited liability company shall be thirty (30) years.

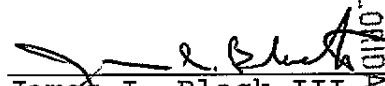
