Article 6. Operating Agreement



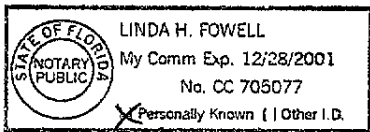


