The undersigned, pursuant to Chapter 608 of the Florida Statutes, hereby makes acknowledges and files the following Articles of Amendment.

1. The name of this limited liability company is Advenir@Homestead, LLC, a Florida limited liability company (the "Company"), whose principal office address is 4780 NW 9th Street, Plantation, Florida 33317.
2. The Articles of Organization of the Company were filed with the Florida Department of State on March 21, 2000.
3. Those certain Articles of Amendment filed with the Secretary of the State of Florida on May 17, 2005 and May 27, 2005 are hereby revoked in their entirety and replaced with these Articles of Amendment.
4. The following amendments shall be made to the Articles of Organization and shall be effective as of the date on which (a) the defeasance ("Defeasance") of that certain loan (the "Loan") from Bank of America, N.A., a national banking association ("Original Lender") as evidenced by that certain Promissory Note dated as of April 26, 2000 (the "Note") made by Borrower to such Original Lender in the original principal amount of \$3,584,000.00, and assigned by Original Lender to Wells Fargo Bank, N.A. (f/k/a Wells Fargo Bank Minnesota, N.A.), ("Lender"), as Trustee under the Pooling and Servicing Agreement dated September 1, 2000 (as amended from time to time, the "Pooling and Servicing Agreement") for Banc of America Commercial Mortgage, Inc., Commercial Mortgage Pass-Through Certificates, Series 2000-2 has been closed, and (b) that certain loan from Lehman Brothers Bank, FSB, a Federal stock savings bank ("New Lender") being made in connection with the defeasance has been funded.
  - a. Article II of the Articles of Organization of the Company is deleted in its entirety.
  - b. Article IX of the Articles of Organization of the Company is deleted in its entirety.

- c. Article XI the Articles of Organization of the Company is deleted in its entirety and replaced with the following:

The management of the Company is reserved to members, or officers of the members, that will be referred to as managing members. The name and address of the managing member that will serve as the sole managing member is as follows:
