**ARTICLES OF ORGANIZATION  
OF  
MEDICAL SPECIALTY PROCEDURES L.C.**

**FIRST:** The name of this limited liability company shall be Medical Specialty Procedures L.C. (the "Limited Liability Company").

**SECOND:** The period of duration for the Limited Liability Company shall be perpetual unless sooner dissolved in accordance with the laws of the State of Florida.

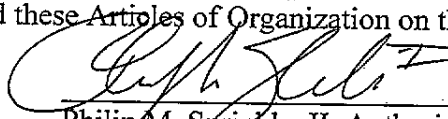

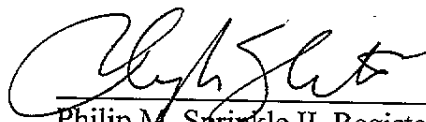
