ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY MOTOMACHINE, L.L.C.

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I NAME

The name of this Limited Liability Company shall be MOTOMACHINE, L.L.C., and its principal office shall be located at 6927 Vickie Circle, Unit D, West Melbourne, FL 32904, in the County of Brevard, State of Florida, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II - ADDRESS

ARTICLE III - PURPOSES AND POWERS

In addition to the powers authorized by the laws of the State of Florida for limited liability companies, the general nature of the business or businesses to be transacted, and which the limited liability company is authorized to transact, shall be as follows:

To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign for any domestic or foreign state, government, or governmental authority or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.
- 5. ARTICLE VI – MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of the two members identified in Article V herein.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining member or members shall have the right to continue the business on unanimous consent of the remaining members.
