ARTICLES OF ORGANIZATION OF JT LIMITED, L.L.C.

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Act, hereby adopts the following Articles of Organization.

ARTICLE I

The name of the Limited Liability Company shall be JT LIMITED, L.L.C.

ARTICLE II ADDRESS

The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which that Member otherwise would be entitled.
