The undersigned, for the purpose of forming a limited liability company bider the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

#### **ARTICLE 2 - ADDRESS**

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.
