ARTICLES OF ORGANIZATION OF
DUVEL PAINTING COMPANY, L.L.C.

ARTICLE I
NAME

The name of this Limited Liability Company shall be DUVEL PAINTING COMPANY, L.L.C. (the "Company").

DURATION

ARTICLE IX
