

**ARTICLES OF ORGANIZATION
OF
OLD VINES, LLC**

**ARTICLE I
NAME**

The name of the limited liability company (hereinafter referred to as the "Company") is OLD VINES, LLC.

**ARTICLE II
ADDRESS**

ADMISSION OF NEW MEMBERS

Members of the company have the right to admit new members. Additional members may be admitted on the unanimous written consent of the existing members. Existing members shall determine the amount and nature of contributions by new members at the time new members are admitted.


ARTICLE V11




