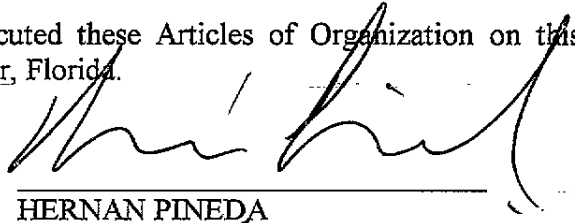
ARTICLE VII – CONTINUATION OF BUSINESS

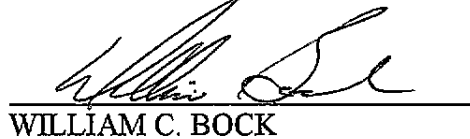
ARTICLE VIII – EFFECTIVE DATE
