ARTICLES OF ORGANIZATION OF MARCO CENTER, L.L.C.

I. NAME

7.2 Shlomi Laria shall not have the right to sell his interest in this company to a third party without first offering it to the other members for purchase. The appraiser shall be selected by the selling and buying members jointly. If they cannot agree on an appraiser then each shall select one and the two appraisals shall be averaged.
