ARTICLES OF AMENDMENT

TO

ARTICLES OF ORGANIZATION

OF

RIVERVIEW ASSOCIATES, LLC



The undersigned, for the purpose of amending the Articles of Organization of RIVERVIEW ASSOCIATES, LLC, a Florida limited liability company, hereby makes, acknowledges, and files the following amendment to its Articles of Organization, pursuant to Section 608.411, Florida Statutes.

The Articles of Organization of RIVERVIEW ASSOCIATES, LLC, were filed with the Florida Department of State on March 31, 2000, subsequently amended by amendment filed September 1, 2000, and were assigned Document Number L00000003681.
