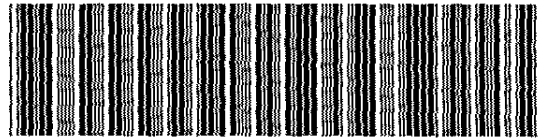

**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF ORGANIZATION

The undersigned being one of the Members named in the Articles of Organization of TD FULFILLMENT SERVICES, L.L.C., a Florida limited liability company (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends the Articles of Organization of the Company as set forth below:

1. The name of the Company is TD FULFILLMENT SERVICES, L.L.C.
2. The Articles of Organization for TD FULFILLMENT SERVICES, L.L.C. were filed with the Florida Department of State on April 3, 2000.
3. Article VI of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

**"ARTICLE VI.  
MANAGEMENT**

The Limited Liability Company shall be managed by three (3) to six (6) managers in accordance with the provisions of Article 1.1 of the Operating Agreement of the Limited Liability Company.

4. These Articles of Amendment shall be effective upon filing with the Florida Department of State.

5. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
