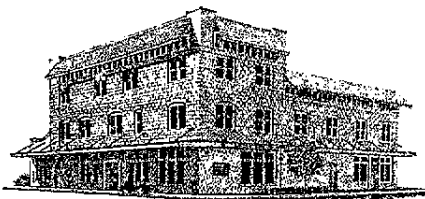

ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
FOR

ADVANCED TITLE AND SETTLEMENT SERVICES, LLC

Pursuant to Section 608.411, Florida Statutes (2000), the undersigned, as the sole Class A Member of Advanced Title and Settlement Services, LLC (the "Company"), hereby certifies to the following for the purpose of amending the Articles of Organization for the Company:

1. The name of the Company is ADVANCED TITLE AND SETTLEMENT SERVICES, LLC, a Florida Limited Liability Company.
2. The Articles of Organization for the Company were filed with the Florida Department of State on March 24, 2000.
3. Article VII of the Articles of Organization for the Company is amended to read as follows:


ARTICLE VII
MEMBERSHIP CLASSES

The Company shall have twenty-six (26) Classes of Membership which shall be designated as "Class A" through "Class Z". The rights, obligations, and responsibilities associated with each Class of Membership shall be set forth in the Operating Agreement for the Company.
