ARTICLES OF AMENDMENT
TO THE
ARTICLES OF ORGANIZATION
OF
LOCATEADOC, LLC

Pursuant to the provisions of Section 608.411 of the Florida Statutes, LocateADoc, LLC, a limited liability company organized and existing under the laws of the State of Florida, hereby adopts the following Articles of Amendment to its Articles of Organization:

SECTION I - NAME OF LIMITED LIABILITY COMPANY

The name of the limited liability company is LocateADoc, LLC.

SECTION II - DATE OF FILING OR ARTICLES OF ORGANIZATION

The Articles of Organization were filed on March 29, 2000, effective April 1, 2000.

SECTION III - AMENDMENT OF ARTICLES OF ORGANIZATION

Article VI of the Articles of Organization is hereby deleted in its entirety and the following substituted in lieu thereof:

"ARTICLE VI - RIGHT TO ADMIT ADDITIONAL MEMBERS

Any member shall be entitled to assign his, her or its entire membership interest in this limited liability company at any time, upon (i) the written consent of a majority in interest of the Members of this limited liability company, and (ii) the written consent of the Manager of this limited liability company. Effective upon such assignment, the assignee of such interest shall be admitted as a member if he, she or it is not already a member and shall enjoy full rights and powers of a member of the limited liability company including, without limitation, the right to vote the interest so assigned."

IN WITNESS WHEREOF, the undersigned has executed these Articles of Amendment to the Articles of Organization on December 21st, 2011.
