The Limited Liability Company is to be managed by its members and the names and addresses of its managing members are:

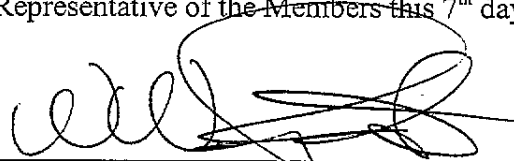
