AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF FIRST TEAM PROPERTIES, LLC

The Articles of Organization of First Team Properties, LLC, a Florida limited liability company (the "Company"), were filed with the Florida Department of State on April 6, 2000. Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "Act"), the Articles of Organization of the Company are hereby amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the Company is First Team Properties, LLC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - REGISTERED OFFICE AND AGENT

ARTICLE IV - MANAGEMENT

The Company is a manager-managed limited liability company and the manager of the Company is W. Warner Peacock.
