Pursuant to the provisions of Section 608.411, Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Organization.

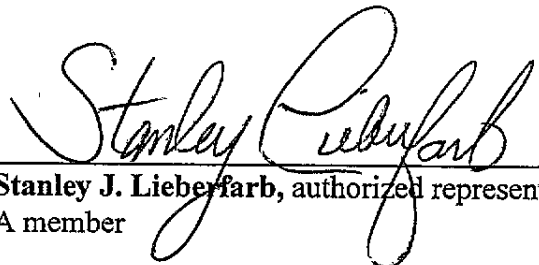
- FIRST:** The date of filing of the Articles of Organization was April 5, 2000 and assigned document number L00000003925.
