3. Registered Agent. The name of the initial registered agent, and the address of the initial registered office, of the Company is:

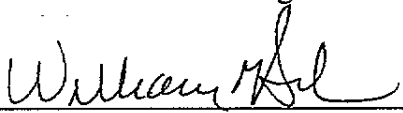
