FIRST: The name of the limited liability company (hereinafter called the "Company") is Lake Leasing LLC.

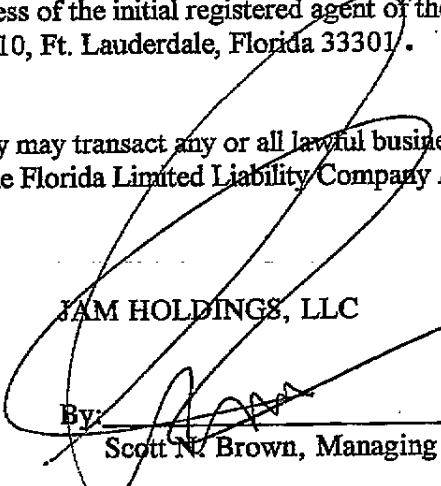
SECOND: The mailing address and street address of the principal office of the Company is 19926 Northeast 36<sup>th</sup> Place, Aventura, Florida 33180.
