ARTICLES OF ORGANIZATION OF BETTER WAYS TO HEALTHY DAYS, L.L.C.

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") is BETTER WAYS TO HEALTHY DAYS, L.L.C.

ARTICLE II. ADDRESS
