1. Recital. The Member of the LLC has designated Robin Bowerfind as an "authorized representative" as that term is defined in §608.402 of the Limited Liability Companies Chapter of the Florida Statutes' Business Organizations Title, for purposes of executing and filing these Articles of Organization, and any other documents or certificates that may be required to be filed on behalf of the LLC with the Florida Department of State from time to time.
