ARTICLES OF ORGANIZATION

ARTICLES I - NAME

This name of the limited liability company is LINE CERAMIC, L.L.C.

ARTICLE II - ADDRESS

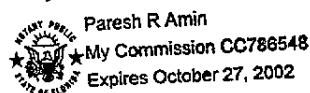

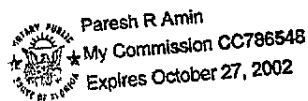
