AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR 610 EAST 10TH STREET, L.L.C.

Pursuant to the provisions of Section 808.411(5), Florida Statutes (2001), Samuel M. Easton, Jr., as managing member of 610 EAST 10TH STREET, L.L.C., hereby amends and restates in their entirety those certain Articles of Organization of 610 EAST 10TH STREET, L.L.C. dated April 13, 2000 (the "Prior Articles") to make such changes as agreed to by the current Members of 610 EAST 10TH STREET, L.L.C.
