
ARTICLE VII - Admission of Additional Members



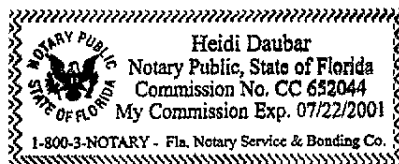


