**ARTICLES OF ORGANIZATION  
OF  
FINANCIAL GATEWAY TO ASIA, LLC  
  
A LIMITED LIABILITY COMPANY**

1. **Name.** The name of the limited liability company is **FINANCIAL GATEWAY TO ASIA, LLC.**
2. **Purpose.** The purpose of this limited liability company (hereinafter "LLC") may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.

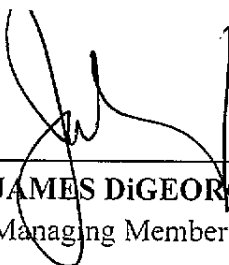
