### ARTICLES OF ORGANIZATION OF PONDEROSA, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be PONDEROSA, L.L.C. ("Company")

#### ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be 26 Randy Lane, Fort Myers Beach, FL 33919.

#### ARTICLE III -- DURATION

#### ARTICLE IV

#### ARTICLE VII -- ADDITIONAL CAPITAL CONTRIBUTIONS

#### ARTICLE VIII -- ADMISSION OF NEW MEMBERS
