Pursuant to §608.411 of the Florida Limited Liability Company Act, the undersigned Authorized Representative of this Florida limited liability company files these restated and amended articles of organization which shall supersede the articles of organization that were originally filed on April 18, 2000 and further amended on April 19, 2000.


Article III – Duration
